Your carrying charges are due on the 1st of each month by check or money order. If payment is not received by 4:30pm on the 10th you will be assessed a \$50.00 late charge. If the 10th falls on a weekend your payment must be in the drop box no later than 8:30 on Monday. If payment has not been made you will received a notice of default.

Attorney Referral

If your payment is not in the office by 8:00am on the 21st your account will be forwarded to the attorney. The current cost for attorney referrals is \$348.00 for a single member and \$384.00 for two members. This charge is applied to your account the day your account is referred to the attorney.
