

have a debt 30 days old, you will not be eligible to vote. However, you can clear up the debt before the Annual Meeting and be able to exercise your voting rights.


A financial report will be presented by Keli Management.

When you get someone else's mail in your box., be considerate and write either "return to sender" or "not at this address" and put it in the outgoing mail or in a mail




I live at River Park, I should know this...

- I should know that Lock-outs during office hours are \$5.00 and after hours lock-outs are \$30.00.
- I should know that any complaints must be submitted in writing to the office in order for a complaint to be addressed.

Garbage Disposals

A garbage disposal is a machine that is primarily used to shred food waste into super small pieces that won't clog pipes. It's smart to run your disposal regularly and to keep it clean. The proper use of the garbage disposal could help reduce service requests. Items you should not put down the disposal unit are: banana peels, potato skins, coffee grounds, bones, prease and any stringy food. When you use your disposal, turn on the cold water before using the disposer and please put small amounts of food in the disposal at a time. Occasionally run some ice cubes through the unit to keep the blades in your disposal sharp.... Rule of thumb: If you can't chew it, your disposal can't handle it.



Please be reminded of the Policy regarding smoke alarm charges to members who have tampered with their smoke detectors.

There is a reason we frequently remind you to check your smoke detector—we care about our member's well-being. It is important that your smoke detector be functional, not only for your protection but for your neighbors as well. Having a working smoke detector in your home decreases your risk, as does having a fire escape plan. Please take this seriously. If your detector is malfunctioning or you need the batteries replaced, let us know—we will be happy to send someone to your home to take care of the problem.
