

#### What Happens When I Move?

Here's a reminder...

You do need to call the office and set an appointment to sign your Intent To Vacate. This gives River Park the right to put your membership on the market for sale. You are required to bring in your Move-In

packet at that time. This includes your Membership Certificate, Brochures and your Occupancy Agreement. You will be responsible for the monthly carrying charges and utilities until an applicant is approved and moves

into your unit.

Also, the responsibility of the selling member is having the unit rehabilitated and brought back to standard as it was done for you when you moved in. If you can find your own buyer
