Carrying Charge

Your carrying charges are due on the 1st of each month by check or money order. If payment is not received by 4:30pm on the 10th you will be assessed a \$50.00 late charge. If the 10th falls on a weekend your payment must be in the drop box no later than 8:30am on Monday. If payment has not been made you will received a notice of default on the 11th, along with a \$50.00 late fee. You will then have 10 additional days to pay your carrying charge before it is sent to the Attorney for non-payment. Attorney fees & court costs are \$400.00 for Single households and \$438.00 for Two persons.

Late fees are applied to any unpaid balance left on your account after the 10th. You can not carry a balance on your account without a late fee.
